RFID Technology

Radio frequency identification (RFID) is changing the way businesses operate, speeding inventory pass-through and altering the inventory logistics landscape. The most common RFIDs are passive tags – basically tiny, microchip-based targets. When their antennae are hit with an incoming radio signal, the signal provides just enough energy for their microscopic circuitry to power up briefly and transmit a response. At libraries, the response can trigger an alarm, notifying personnel that someone may be leaving with a book that hasn't been checked out. For cars with a window-mounted transporter imbedded with an RFID tag, the response raises a gate, signifying a toll has been paid. For Wal-Mart, the world's largest retailer, the technology means getting the right item to the right place, right on time – and the potential for saving millions, or likely billions, of dollars in the process.

Our speaker is a pioneer in the RFID field. He is Paul Reed who is President of Business Resources Solutions, a Brentwood purveyor of barcode technology and services. Paul Reed's company got involved six years ago when Wal-Mart and the federal government began embracing it. His company developed a \$20,000 software package that allows supply chain businesses to become RFID-compatible. The Windows based software generates and reads the RFID tags that go on shipping pallets

holding goods.

Paul Reed began his business career in the auto identification industry in 1989 with a focus on industrial bar code application and management tracking using bar code services. He formed Business Resource Solutions (BRS) in 2001. The primary focus of the BRS Company is on bar code products from labels, ribbons, to bar code printers, scanners, Wireless Equipment, and RFID. They sell, support, and provide expertise in

these fields.



Paul will offer strategic insight on how your business or industry will be impacted by bar coding, RFID, wireless and other digital technologies in the coming years. Paul has spoken with countless plants offering real world solutions for their auto ID needs. Paul will be assisted in the presentation to

the AITP Nashville Chapter by Hugh Kirkpatrick who is Business Development Manager of BRS.

Paul's research and writing has been featured in business journals, trade magazines, and newspapers. Paul has a BA degree from Trevecca University. He and his family live in the Brentwood area. For fun, Paul says they like to do long distance bicycling.

This should be an interesting program on a subject that may impact many IT people. Please remember that we have moved our meeting location back to the Holiday Inn Select – Vanderbilt.

Since the Chapter pays for reserved meals, No Shows will be billed at the reservation price of \$20.00 for Members, and \$30.00 for Guests.

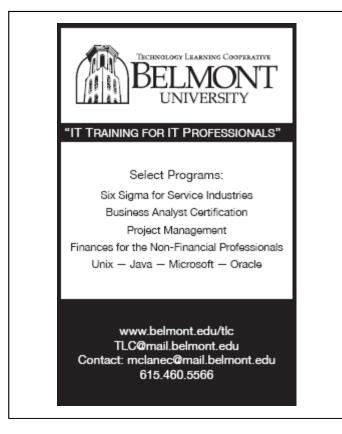

MESSAGE FROM THE PRESIDENT

Who's your favorite team? The Red Sox, Cardinals, Braves, Cubs? Hopefully, none of you said the Yankees, but that's a topic for another place and time. For here and now, have you ever thought about what makes them a team? Is it the uniform? The presence of a coach? A team nickname, along with a mascot? In the Wisdom of Teams, Jon Katzenbach and Douglas Smith say teams are committed to common goals, have complementary skills and abilities, and hold each other accountable. The teams mentioned above would certainly qualify, but what about the team you are on at work? Does it fit this definition? Victoria Davis, Vice President of Strategic Operations at Dale Carnegie Training, believes it should. Ms Davis presented a scaled-down version of an exciting workshop on how to engage team members to help create a common purpose, examine and define team values, and create a team environment of mutual support.

Having a common purpose is the glue that holds teams together. For most of us our work teams were established along with a purpose even before we became members; we chose whether to accept the purpose and become a member or seek another team. This is seldom true for teams formed in response to specific projects or challenges; they must explicitly create a common purpose, using the experience and ideas of all team members. Either way, the common purpose should be understood and supported by all team members. This allows each team member to use their unique skills and abilities to enable more efficient problem solving and decision making. Furthermore, with strong support for the common purpose, team members work through conflict for the good of team goals. The desire to work through conflict becomes a team value.

Ms Davis reminded us that team values are guiding principles that enable us to interact with each other more effectively to achieve better outcomes. Identifying and sharing team values are critical aspects of successful teams. When everyone on the team knows the shared values and acts upon them the team is able to move toward the common purpose without wasting time and effort in conflict making the team is more efficient. Ms Davis suggests all teams openly identify and agree to team values. With team values openly discussed and shared, team members are able to more effectively support each other.

Mutual support is another vital characteristic of successful teams. It takes the form of accepting and using the diversity of skills, abilities, and experience on the team in addition to providing moral and emotional support for other team members in the accomplishing tasks and acting out team values. Ms Davis coached us through a fun, instructive exercise to help us remember ways to be a friendlier person. "Give honest, sincere appreciation." "Become genuinely interested in other people." "Make the other person feel important—and do it sincerely." Performing these activities go directly to the heart of providing support to your fellow team members and making them, thus your entire team, more successful.

There's not much we can do to make our favorite sports team successful other than go to games and cheer loudly. But we know how to make our work teams successful... start with making sure the team knows and supports a common purpose, identify and share values, and support each other. The common purpose of AITP Nashville is to be *where IT professionals meet*.

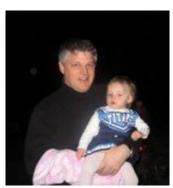
